**02<sup>ND</sup> AMENDMENT TO THE ELECTION NOTIFICATION FOR CHAPTER AND  
ZONAL ELECTIONS, 2020**

**Whereas** the Election Officer has issued Notification dated 03<sup>rd</sup> October, 2020 for the conduct of Chapter and Zonal Council Elections, 2020 for Four (4) Zonal Councils and Twenty-Three (23) Chapters Councils of Indian Institute of Insurance Surveyors and Loss Assessors ("IIISLA" or "the Company");

**Whereas** the said Notification was partially modified vide Amendment Notification dated 6<sup>th</sup> October, 2020 to enable filing of Nomination Form (s) in electronic mode and for other connected matters;

**Whereas** vide Order of the Hon'ble High Court of Delhi ("the Court") in Writ Petition (C) No 11462/2019 dated 15<sup>th</sup> October, 2020, the IIISLA on the suggestion of the Court has agreed to extend the period for making payment of subscription dues, and accordingly extended the period upto 6 p.m. on 22<sup>nd</sup> October, 2020 and published, in the website of IIISLA, the revised list of members eligible to vote in the election;

**Whereas** it was brought to the notice of IIISLA and the Election Officer that some of the contesting Candidates are using the logo of IIISLA (Logo reproduced on margins of this notification) for campaigning their candidatures to the members;



**And Whereas** the agency i.e. National Securities Depository Limited (NSDL) entrusted the task to providing e-voting facility has expressed the time constraints due to revision in the list of members eligible to vote, to commence the voting on the scheduled date i.e. 28<sup>th</sup> October, 2020, and hence after carefully examination of the matter with the IIISLA, the undersigned hereby amends the Election Notification dated 03<sup>rd</sup> October, 2020 read with the amended Notification dated 06<sup>th</sup> October, 2020 to the following extent:

1) The Election Notification, 2020 dated 3<sup>rd</sup> October, 2020 is amended and should be read as follows:


a) For the columns at Sr. No. 10, 11 and 12 of the Table for Chapter and Zonal Elections Schedule, the following is hereby substituted:

2) The logo of IISLA (supra) is the proprietary and trademark of IISLA. Any use of the said logo whether, directly or indirectly, in any material, whether in print or electronic or other medium, aimed at promoting their candidature in the ensuing elections is strictly prohibited and amounts to professional mis-conduct. Hence, any person including a candidate for the Election (s) is advised strictly to refrain from using the said logo. Any mis-use or disobeying of this advise, will result in withholding his election results and cancellation thereafter. The decision of Central Council and / or Election Officer is final in this regard.

The other terms and conditions of the Election Notification, 2020 dated 03<sup>rd</sup> October, 2020 and the amended Notification, 2020 shall continue to remain force and hold good.
