**Re: Order No. IRDA/SUR/REG/ORD/071/04/2015 dated 10/04/2015 issued by IRDA in respect of Weblist of surveyors and loss assessors (individual & Corporate) with IISLA Membership**

IRDA has issued the captioned order and has placed it on their website. As per this order, IRDA has removed the previous system of department based categorization of Surveyors, and have replaced it with categorization on the basis of level of membership allotted to the surveyor by IISLA (Indian Institute of Insurance Surveyors and Loss Assessors). The level of membership is defined as Licentiate, or Associate or Fellow. Every surveyor and loss assessor whether a company or firm or individual, shall be eligible to carry on the work as surveyor as per the level of membership allotted by IISLA. This level of membership will be displayed in the Surveyor licenses issued by IRDA. Please note, effectively it will mean that a surveyor will have the same category for survey in all the departments for which he is licensed.

IRDA has also informed that they shall be removing the earlier categorization of 'A' or 'B' or 'C' from the licenses issued earlier in due course and till such time the surveyors can show/submit their IISLA membership certificate along with license for the purposes of empanelment and survey work allocation.

The membership certificate issued by IISLA clearly depicts the categorization (Fellow or Associate or Licentiate) of surveyors on the face of membership certificate. This categorization can also be identified through the membership number written on IISLA membership certificate.

The identification of level of membership of surveyor on IISLA membership certificate can also be recognized with the help of their membership number. Various levels of IISLA Membership are as follow:

Student	Ex. S/N/00051	<b>S</b> indicates Student	2 <sup>nd</sup> letter indicates Zone (North)
Licentiate	Ex. L/S/02351	<b>L</b> indicates Licentiate	2 <sup>nd</sup> letter indicates Zone (South)
Associate	Ex. A/W/05341	<b>A</b> indicates Associate	2 <sup>nd</sup> letter indicates Zone (West)
Fellow	Ex. F/E/02365	<b>F</b> indicates Fellow	2 <sup>nd</sup> letter indicates Zone (East)
