Re: Notice for Subscription Fee for the FY- 2024-25

Members are hereby notified that they would be required to pay their annual IIISLA Membership subscription fee for the current year 2024-25 + GST 18% before 30<sup>th</sup>June, 2024.

Those members, who don't pay their annual IIISLA Membership subscription fee before 30<sup>th</sup>June 2024, "As per article 4 of AOA of IIISLA, are liable to be removed from the membership of IIISLA, as per article 14(iii). However, such of the members removed from the membership of IIISLA are eligible for "readmission membership", after clearing their dues along with "readmission charges", at the discretion of the Council, as per 14 (iii) sub clause.

The relevant clauses of AOA are quoted below for ready reference.

### -Quote

4. Members of the Institute shall pay a one-time admission fee and annual membership fee before his name is entered in the Register of Members. Thereafter a member shall pay an Annual Membership fee as may be prescribed by the Council of the Institute, from time to time.

14(1) The Council may remove from the Register the name of the member of the Institute:

- i. Who is dead.
- ii. From whom a notice of resignation has been received.
- iii. Who has not paid any prescribed annual membership fee required to be paid by him within the stipulated time as per the regulations in force.

A member, whose name has been removed under this sub-clause, may be readmitted, and provided membership after he deposits the dues and "**readmission charges** "demand in his name for previous year / years accumulated, and such "readmission membership" shall be at the sole discretion of the council and in a prescribed manner.
