Dear All the Members

Re: Extension Notice for Subscription Fee for 2022-23 Financial Year

Members were earlier notified that they would have to pay their annualsubscription fee for the current year 2022-23 + GST 18%, along with any previous years outstanding subscription fee before 30thJune, 2022.

The Central Council in its vested powers have decided to extend the subscription payment last date from 30th June 2022 – 20thJuly 2022, as per the members request for a last chance to pay without readmission of FY 22-23. The CC would like to confirm that this extension is the last and the CC will be implementing the decided readmission after 20/07/2022.

The members, who have not paid the annual subscription fee before 20th July 2022, asper article 4 of AOAofIIISLA, are liable to beremoved from the membership of IIISLA, as per article 14(iii). However, such of the members removed from the membership of IIISLA are eligible for readmission, after clearing the dues along with readmission charges, at the discretion of the Council, as per 14 (iii) sub clause. The relevant clauses of AOA are quoted below for ready reference.

- 4. Members of the Institute shall pay a onetime admission fee and annualmembership fee before his name is entered in the Register of Members. There after a member shall pay Annual Membership fee as may be prescribed by the Council of the Institute, from time to time.
- 14(1) The Council may remove from the Register the name of the member of the Institute:
- i. Who is dead:
- ii. From whom a notice of resignation has been received;
- iii. Who has not paid any prescribed annual membership fee required to be paid by him within stipulated time as per the regulations inforce;

Provided that a member, whose name has been removed under this subclause, may be readmitted after he deposits the dues with arrears and readmission charges and such readmission shall be at the discretion of the council and in the prescribed manner.
