In its endeavour for continuous professional development of its members, U.P. Chapter had successfully conducted series of one day Technical Training Programmes at Lucknow, Kanpur, Khalilabad, Mirzapur, Varanasi and seminar at Allahabad after IRDA Gazette Notification dated 13.03.2013.

In this chain, the UP Chapter is now organizing a two day Seminar on important issues confronting the insuring public in motor claim settlement **on 20/02/2016 (Saturday) & 21/02/2016 (Sunday)**.

The theme of the seminar is to dwell upon the Scope & Limitation of the peril “**By Accidental External means**” in Motor Package Policy. In this context interpretation of term “**Accidental**” & “**External**” needs to be further elaborated.

Admissibility ,extent of admissibility and inadmissibility of Insurer’s liability in under mentioned situations needs lucid explanations.

1. **A.** Panel hood/bonnet in a running car got blown open and hit the windshield glass to break it. This led to damage to windshield glass and panel hood.  
**B.** Upon application of brakes on a turn a container body hit the cabin of a prime mover to damage it.
2. Upon application of sudden brakes-  
**A.** The head of a co-driver &/or driver hit the windshield glass from inside leading its breakage.  
**B.** The girders loaded in a goods carrying vehicle broke loose of the fasteners, shifted forward leading to damage/break the back wall of a cabin.
3. **A:-** A loaded dumper with its hydraulic jack open, moved forward with the result its body tilted, the jack got bent/broken and finally the body rested on the ground damaging its sub frame and Chassis.  
**B:-** The wooden body of an overloaded goods carrying vehicle with sugar cane uprooted from its mountings and was thrown off on road side.
4. **A.** An unknown person made scratches by some sharp object on all round the body of a car.  
**B.** A car when parked near a kennel and a pet dog by his teeth damaged its bumper.
5. Fresh accidental damages occurred on a pre-existing accidental damage.

**This seminar is outlined to provide a platform to all stake holders for healthy deliberation.**

The speakers in this seminar will comprise of Officials from General Insurance Companies, Experts on the subjects and insurance surveyors across the country.

# HISTORY OF ALLAHABAD

Allahabad also known by its original name Prayag is one of the largest cities of the North Indian state of [Uttar Pradesh](#) in [India](#). Although Prayaga was renamed *lhabad* in 1575, the name later became Allahabad in an [anglicized](#) version in Roman script. The city is situated on an inland peninsula, surrounded by the rivers [Ganges](#) and [Yamuna](#) on three sides, with only one side connected to the mainland Doab region, of which it is a part. This position is of importance in [Hindu](#) scriptures for it is situated at the confluence, known as [Triveni Sangam](#), of the holy rivers. As per Rigveda the [Sarasvati River](#) (now dried up) was part of the three river confluence in ancient times. It is one of four sites of the [Kumbh Mela](#), an important mass Hindu [pilgrimage](#).



The ancient name of the city is Prayag ([Sanskrit](#) for "place of sacrifice"), as it is believed to be the spot where [Brahma](#) offered his first sacrifice after creating the world. Since its founding, Prayaga renamed Allahabad has played an important role in the history and cultural life of India.
