## **IIISLA Benevolent Fund Scheme 2018-19**

- 1. In the light of members view and minutes recorded thereof during the meeting held on 24.03.2018 at Hyderabad, the IBF membership is now not mandatory. The Central Council has passed a necessary amendment in 'Rules & Regulation' of IIISLA Benevolent Fund.
- 2. In 2017-18 the IBF committee has received 19 death and 5 critical illness claims as against 4 death and 4 critical illness claims in 2016-17. This has created a huge pressure on IBF corpus fund. So in order to keep the fund healthy and viable, the committee has decided following subscription & compensation for 2018-19.

  - (b) Age proof (birth certificate or high school certificate or any other legal age proof)
  - (c) Copy of valid license
  - (d) Amount as one time membership for corpus fund + annual subscription, for members becoming eligible as on 1.4.2018 as per age (*Refer table above*) and Rs.6490.00 for members became eligible in 2016-17.

**Note:** Incomplete and unsigned form may lead to rejection or 'hold' of membership and also coverage.

- 6. The cover for existing &valid members of IBF will remain valid till 30.05.2018. So members are requested to send their dues before 30.05.2018 for uninterrupted cover of IBF.
- 7. The cover will cease for 90 days from the receipt of subscription for existing & valid IBF member, if their subscription cheque and application reaches after 30.05.2018.

- 8. For new members becoming eligible for IBF member ship on 1.4.2018, cover will commence after 30 days from the receipt of the application form and dues at IIISLA, Head Office.
- 9.
